B. Approval Condition

1. Application & Limitation

- 1) Preventing splash of fuel oil, lube oil and other flammable oils from piping lines including flanges and joints in engine rooms or other enclosed spaces in compliance with Regulation II-2/4.2.2.5.3 of SOLAS 1974 as amended.
- Installation of the tape is to be carried out in accordance with the Manufacturer's instruction.
- 3) The Mareflex AntiSpray Tape cannot be used for pipes insulation or as replacement for pipe gaskets and sealings.
- 4) The extent of use is limited to spray shielding applications on oil pressure pipes located above the floor plates and which have no insulation in way of the joints.
- 5) Use is restricted to easily accessible positions where the integrity of the application may be inspected regularly and new covering applied after removal for maintenance purposes.
